WHEREAS, the Sheriff Automated GC 26731 Org 1455 requires \$87,500 to meet expenditures associated with the purchase and up-fitting of patrol vehicles and trailer; and

WHEREAS, \$87,500 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Sheriff Automated GC 26731 Subclass 17654 to fund these expenditures; and

WHEREAS, \$87,500 is not included in the FY 2016-17 adopted appropriations of the Sheriff Automated GC 26731 Org 1455; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Sheriff Automated GC 26731 Org 1455 as follows:
