WHEREAS, the Library-Measure B Capital Improvements Organization 7530 requires additional appropriations in the amount of \$1,224,000 for a transfer out to the Department of Public Works and Planning for contracted architectural expenses related to the construction of a new building for the Clovis Regional Library; and

WHEREAS, the development of the Clovis Regional Library building will require conceptual and schematic designs for presentations to the public, and for final construction; and

WHEREAS, architectural services shall be provided by Dyson Siegrist Janzen Architects, Inc.; and

WHEREAS, the \$1,224,000 is available in the Fund Balance of the Fresno County Library-Measure B Fund 0107, General Subclass 10000; and

WHEREAS, the Fresno County Library-Measure B fund shall be used exclusively for public library construction, acquisition, programs, and operations within the County; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations of Library-Measure B Capital Improvements Organization 7530; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths (4/5) vote of the Board of Supervisors;

1 NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax
2 Collector is authorized to increase the appropriations in the FY 2017-18 Library-
3 Measure B Capital Improvements Organization 7530 as follows:


