WHEREAS, the County of Fresno has received approximately \$81,600,000 from the United States Department of Treasury (US Treasury) Coronavirus Aid, Relief, and Economic Security Act, Coronavirus Relief fund and

WHEREAS, said monies must be transferred from the Auditor-Controller/Treasurer-Tax Collector's Organization 1031 to Internal Service Funds and Special Revenue Funds and

WHEREAS, said monies are not included in the FY 2019-20 appropriations and estimated revenues of the County Administrative Officer Organization 3663; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 County Administrative Officer Organization 3663 as follows:


