SUMMARY OF PROPOSED ORDINANCE

The Proposed Ordinance would add Chapter 9.10 - Community Cat Population Management which includes: (1) Section 9.010.10 Definitions, which describes definitions related to the chapter; (2) Section 9.010.020 which describes funding; (3) Section 9.010.030 - Community Cat Protocol, which describes the process; and (4) Section 9.10.040 -Records, which describes the keeping of Community Cat records separate from shelter animal records.
