Local supervising agencies will be reimbursed to adopt an industry standard, electronic format for the submission of data of an individual on probation, mandatory supervision, post release community supervision, and all other types of supervised release. Jurisdictions may also be reimbursed if modifications are needed to their case management system to add additional supervision types. Refer to Attachment A for technical specifications.

The Fresno County Probation Department would plan to rebuild our legacy DOJ SRF interface into a new interface which would also conform to the SRF SRQ file format. The current Probation SRF interface was developed 7 years ago and was primarily integrated into our legacy case management system. Over the recent years we have modified the interface to work with our new case management system PRI MS (Probation Records and Information Management System).

The proposed interface will allow for improved and efficient integration into our newer PRI MS framework, our department would rebuild the interface ground up into a new process. In addition to conforming to the new SRQ file format, this interface will allow better error checking, less data sync issues with DOJ and improved quicker daily processing. Since this new integration would be built into PRI MS, management and useability would also be improved since IT staff would no longer need to work with another application and can instead use PRI MS.

Our department would use a single contractor to perform the development work since our case management software is developed and maintained internally by Probation department IT staff. The plan development time with internal testing is estimated to take two months. Once the system is tested and working internally, we would then work with the DOJ SRF team to run through SRF validation and test plan before going live in production.

The purpose of this Memorandum of Understanding (MOU) is to solidify an agreement between the CA DOJ and the Fresno County Probation Department (FCPD) from January 1, 2021, through May 31, 2023.

On October 1, 2020, the CA DOJ was awarded the Fiscal Year (FY) 2020 Sex Offender Registration and Notification Act (SORNA) Reallocation Grant to further sex offender registration and notification in California through enhancements of submissions to the SRF. Funding from the FY 2020 SORNA Reallocation will be used to reimburse the FCPD for necessary updates to comply with new SRF requirements, mandated by Penal Code (PC) section 14216(c), effective January 1, 2021.

Background:

The CA DOJ provides two technology formats for the submission of supervised release data. The first allows for the manual submission of data via the California Law Enforcement Telecommunications System (CLETS), and the second is an electronic Secure File Transfer Protocol (SFTP). Currently counties are sending this information using SFTP, despite outdated technology, security limitations, and/or not allowing for national information exchange. Many county systems were built in the late 1990s and early 2000s, and as new supervision types were instituted in California, counties did not have the funding to update their systems with these new record types.

The CA DOJ is aware that many counties lack the necessary funds to make the appropriate updates to send all supervision types, or to conform to new industry standard data file formats to electronically submit supervised release data. This project will enable the CA DOJ to reimburse local supervising jurisdictions in implementing an industry standard format to electronically submit offender data on post-conviction probation, mandatory supervision, post-release community supervision, and all other types of supervised release. Completion of this project will advance SORNA in California through technological enhancements that will improve the exchange and data integrity of sex offender registration and notification information at both the state and federal levels.

Activities:

With funding from the FY 2020 SORNA Reallocation, the FCPD will make modifications needed to comply with the mandates of PC section 14216(c), as noted below:

- 1. Rebuild the legacy CA DOJ SRF interface into a new interface which would also conform to the SRF SRO file format; and
- 2. Complete internal testing of new interface and run system through SRF validation and test plan before going live in production.

Funding:

Funding to support the items outlined above shall not exceed \$25,600.00.

The CA DOJ agrees to the following:

- 1. Provide funding to the FCPD to complete necessary updates to comply with the mandates of PC section 14216(c).
- 2. All assistance needed to meet compliance will be a joint effort between the CA DOJ's SRF Team and the FCPD's project manager (PM).
- 3. Grant administration, monitoring, reporting, and invoice processing will be completed by the CA DOJ's Grant Analyst with assistance from the FCPD.

The FCPD agrees to the following:

- 1. Submit invoices on a quarterly basis, to the CA DOJ's Grant Analyst for reimbursement.
 - o Refer to Exhibit A, Payment Processing Requirements, for directions on how to submit invoices for review, approval, and payment.
 - o Refer to Exhibit B, Budget Table, for the description and costs associated with this MOU.
- 2. Provide the CA DOJ's SRF Team PM with quarterly status reports on the progress of the project.
- 3. A final report summarizing all procurement activities and project status must be submitted to the CA DOJ's Grant Analyst and SRF Team PM within thirty (30) days after the close of this MOU.
- 4. The CA DOJ will not be held responsible for late invoices.

Miscellaneous Provisions:

- This MOU does not confer, grant, or authorize any rights or privileges to any entity or person other than the CA DOJ or the FCPD.
- All reports, notices, requests, and/or correspondence shall be forwarded to the CA DOJ's SRF Team PM and Grant Analyst at CJISGrant@doj.ca.gov.
- The CA DOJ reserves the ability to extend the term of this MOU, up to one full calendar year, should unanticipated delays or other project activities adding value warrant such an action. Extensions will be contingent upon federal approval.
- Invoices can be submitted up to thirty (30) days past the grant term end date. Any invoice received after that date will not be paid for by the CA DOJ or the granting agency.

All parties agree to indemnify and hold harmless one another from any and all claims, liabilities, or losses. Neither party shall be liable for any unforeseeable event beyond its reasonable control not caused by the fault or negligence of each party which includes, but is not limited to, an act of terrorism, war, riot, civil disobedience, strikes, labor disputes, epidemic, power outages, sabotage, flood, drought, earthquake, storm, fire, pestilence, lightning, or any other natural catastrophes, for the duration of this MOU.

Budget Contingency Clause

It is mutually agreed that if the Budget Act of the current year and/or any subsequent years covered under the agreement does not appropriate sufficient funds, this agreement shall be of no further force and effect. In this event the CA DOJ shall have no liability to pay any funds whatsoever to provider or to furnish any other considerations under this agreement and provider shall not be obligated to perform any provisions of this agreement.

If funding for any fiscal year is reduced or deleted by the Budget Act for purposes of this agreement, the CA DOJ shall have the option to either cancel this agreement with no liability occurring to the CA DOJ, or offer an agreement amendment to the provider to reflect the reduced amount. Any amendment for any reason will need to be signed by both parties.
