RESOLUTION

WHEREAS, the laws of the State of California require Fresno County to adopt and maintain a General Plan to guide the long-term development of the County, pursuant to Government Code, Section 65300 et seq.; and

WHEREAS, Government Code, Section 65400(a)(2) requires that an annual report be prepared on the progress in the implementation of the General Plan, and an annual progress on implementation of the County’s Housing Element, including meeting its share of Regional Housing Needs Allocation; and

WHEREAS, the Planning Commission conducted a duly noticed public hearing on the 2022 General Plan Annual Progress Report on February 23, 2023; and

WHEREAS, the Planning Commission received staff’s presentation on the 2022 APR and public testimony and recommended that the Board accept the 2022 General Plan Annual Progress Report and directed the Clerk to prepare Resolution No. 12978 reflecting the Commission’s action; and

WHEREAS, the Board of Supervisors considered the 2022 APR at a duly noticed public hearing on March 28, 2022.


