WHEREAS, the Welfare Advance Fund requires \$381,860 to cover increased expected expenses as an Operating Transfer Out to Aid to Refugees Org 6615; and

WHEREAS, the Social Services Fund 0065, Subclass 17225, Welfare Advance Fund Org 1120 will receive funding from the federal government in the amount of \$381,860 in FY 2021-22; and

WHEREAS, said monies were not included in the FY 2021-22 adopted appropriations and estimated revenues of the Welfare Advance Fund Org 1120; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifth vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2021-22 Welfare Advance Fund Org 1120 as follows:
