By Resolution dated July 9, 2024, the Board of Supervisors of the County of Fresno has granted tentative approval of the petition filed by Dirk Poeschel Land Development Services, Inc, on behalf of Great Bigland, LP, for cancellation of a portion of Agricultural Land Conservation Contract (ALCC) No. 4826 which applies to the real property situated in the County of Fresno, State of California, and is more particularly described in the legal description attached hereto as Exhibit "A", and made a part hereof, describing the 37.29-acre parcel subject to the cancellation petition.

The above-referenced parcel is less than the total acreage of the real property subject to ALCC No.4826 recorded on February 14, 1972 as Instrument Number 12642 in the Official Records of Fresno County, California.

The Cancellation Fee shall be paid, and a Certificate of Cancellation issued prior to approval of the Tract Map Application No. 6343 by the City of Clovis

to subdivide the subject parcel into a residential subdivision. If the Cancellation Fee is not paid within one year of issuance of the Tentative Certificate of Cancellation, the Cancellation Fee must be re-computed by the Assessor's Office and re-certified by the Board of Supervisors.
