WHEREAS, the Agriculture Organization 4010 requires additional funding in the amount of \$350,000 to provide weeds control services for the Road Fund; and

WHEREAS, the Department of Public Works & Planning Roads Organization 4510 will reimburse the Agriculture Organization 4010 for the cost of these services; and

WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Agriculture Organization 40101012; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Agriculture Organization 40101012 as follows:




