WHEREAS, the Sheriff-Coroner-Public Administrator's will receive \$51,136 from the State of California, Office of Emergency Services, 2024 Coverdell Forensic Laboratory Program; and

WHEREAS, the Sheriff-Coroner-Public Administrator's Org 3111 will receive \$110,116 as an Operating Transfer in from the Sheriff's Special Revenue Fund 0095 Criminalistic Laboratory Fund Subclass 17651, Criminalistic Fund Org 1451; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and estimated revenues of the Sheriff Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Sheriff Organization 3111 as follows:


