WHEREAS, the Emergency Medical Services Organization 5244 requires \$590,389 to meet expenditures associated with a year-end accrual transaction; and

WHEREAS, \$590,389 is available in the fund balance of the Emergency Medical Services Organization 5244 to fund these expenditures; and

WHEREAS, \$590,389 is not included in the FY 2019-20 adopted appropriations of the Emergency Medical Services Organization 5244; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Emergency Medical Services Organization 5244 as follows:




