WHEREAS, \$285,332 is available in the fund balance of the Special
Revenue Public Health Fund 0080, Subclass 17351 to fund these expenditures;
and

WHEREAS, \$285,332 is not included in the FY 2015-16 adopted
appropriations of the Contingency Fines & Penalties Fund Org 1151; and

WHEREAS, Section 29130 of the Government Code provides for the
appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-
Tax Collector is authorized to increase the appropriations in the FY 2015-16
Contingency Fines & Penalties Fund Org 1151 as follows:






