WHEREAS, the Tobacco Prevention Program 1153 requires \$180,000 to meet expenditures associated with Tobacco Prevention Program activities and partial expenses for sub-contractors, recognizing \$30,000 of interest funds accrued from prior years and Tobacco Grant fund allocation of \$150,000 for FY 2024-25; and

WHEREAS, \$30,000 is available in the fund balance of Special Revenue Fund 0080, Subclass 17353, Tobacco Prevention Program Organization 1153 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2024-25 adopted appropriations and estimated revenues of the Special Revenue Fund 0080, Subclass 17353, Tobacco Prevention Program 1153; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2024-25 Tobacco Prevention Program 1153 as follows:
