WHEREAS, the Aid to Adoptions Org 6415 will receive \$2,200,146 in revenues as an Operating Transfer In from the Welfare Advance Fund Org 1120 (\$1,225,386), the 1991 Realignment Social Services Org 5246 (\$110,799), and the Protective Services Subaccount Org 6210 (\$863,961); and

WHEREAS, said monies were not included in the FY 2023-24 adopted appropriations and estimated revenues of the Aid to Adoptions Org 6415 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2023-24 Aid to Adoptions Org 6415 follows:
