WHEREAS, On November 15, 2016 the County of Fresno approved deed easements and temporary constructions with the City of Fresno; and

WHEREAS, The County of Fresno will receive funds in the amount of \$131,100 from the City of Fresno for the purchase of eight permanent easements and \$19,431 for the purchase of two temporary construction easements located within Courthouse Park; and

WHEREAS, the \$150,531 of proceeds is proposed to be allocated for facility improvements within Courthouse Park including the purchase and installation of new tables, repair of damaged sidewalks and concrete benches, replacement of trees and improvements to the irrigation system; and

WHEREAS, said monies are not included in the FY 2016-17 adopted appropriations and estimated revenues of the Public Works and Planning Parks & Grounds Organization 7910; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2016-17 Public Works and Planning Parks & Grounds Organization 7910 as follows:
