WHEREAS, the County of Fresno will receive \$281,452 in Federal Funds and \$440,220 in 2011 Realignment Funds for the increase in cost associated with the mandated Intensive Services Foster Care placement payment; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Aid to Families with Dependent Children-Foster Care Organization 6410; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Aid to Families with Dependent Children-Foster Care Organization 6410 as follows:
