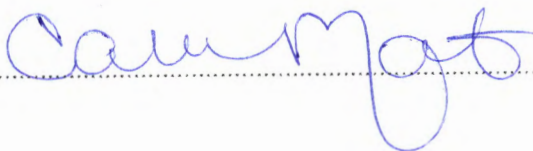

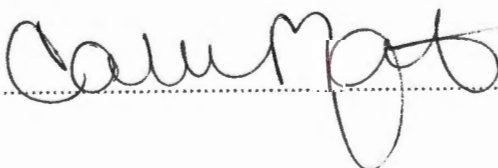

### SUMMARY

NOTICE is hereby given that at its regularly scheduled meeting on May 17, 2022, the Fresno County Board of Supervisors adopted Ordinance No. T-096-381, an Ordinance of the County of Fresno, State of California.

### SUMMARY OF ORDINANCE

On March 24, 2022, the Fresno County Planning Commission recommended approval (6 to 0, with two Commissioners absent and one Commission vacancy) to amend the zoning provisions of the Ordinance Code of Fresno County to address programs identified in Program 10 of the Fifth Cycle Housing Element, recent litigation, and state mandated modifications, in particular Health and Safety Code Sections 17008, 17021.5, 17021.6 and 17021.8 related to employee and farmworker housing by amending the text of sections 803.6, 816.1, 817.1, 855-O.2 and 855-O.3.

In accordance with Government Code Sections 25123, 25131, and 65854 65857, this Ordinance, designated as Ordinance No. T-096 381 shall take effect thirty days after its passage."
