WHEREAS, the Federal Asset Forfeiture Organization 1459 requires \$80,000 to meet expenditures associated with the costs to purchase an Intelligence-Led Policing Package; and

WHEREAS, \$80,000 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Subclass 17658 to fund these expenditures; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2017-18 adopted appropriations of the Federal Asset Forfeiture Org 1459; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


