1. Any/all individuals running for any official public office, or PD or Clerk servicing the public will undergo a full psychological testing;
2. No one with a sex offender record, or any person admitting to having sex with a minor, will be allowed to run for office, nor be hired for a job servicing the public.
3. Or any person with a Domestic or Civil stay away order within the past 25 years is not accepted to serve in any public service role, i.e., includes Teacher, Professor, Clerk, Deputized, or within any public financed or paid facility, or those being paid by and through public tax dollars, or volunteers who are working with any Civil servant nonprofit, i.e. Beautify Fresno.

You are the examples --- read the RULES. PLEASE. DO the correct job for us, the WOMEN OF THE COMMUNITY OF FRESNO! Stop the goons and BULLIES! Now you know what being PREY feels like when it is a constant ingredient of daily life.

Elected leaders are encouraged to promote civility, non-discrimination, and collaboration at local clubs and public meetings by acting as role models, adhering to codes of conduct, and focusing on community problem-solving. This must be done while respecting legal boundaries, such as open meeting laws (like the Brown Act in California) and avoiding interference with private business operations.

Role of Elected Leaders

- Model Behavior: The most effective tool for an elected leader is to lead by example, demonstrating respect and professionalism towards staff, other officials, and the public.
- Promote Civility: Leaders can encourage the adoption of codes of conduct or civility pledges to set a positive tone for discussions and interactions, both in official and unofficial settings.
- Encourage Collaboration: Officials can facilitate partnerships between public agencies, private organizations, and non-profits to address community challenges, emphasizing shared values and common ground.
- Uphold Fundamental Rights: Leaders are sworn to uphold the Constitution, which includes protecting the right to free speech and ensuring non-discrimination based on factors like race, religion, gender, or disability.
- Focus on Issues, Not Personalities: To foster productive dialogue, officials should focus on attacking community problems rather than engaging in personal attacks or questioning motives.
- Explain Legal Limits: When applicable, elected leaders should clearly explain when requests or demands are beyond the scope of local government authority to avoid unproductive debates.

Respecting Business Rules and Legal Boundaries

Elected leaders must navigate legal and ethical constraints in their public engagement:

- **Open Meeting Laws:** In public meetings, elected officials must comply with open meeting laws (e.g., the Brown Act), which mandate transparency and the public's right to attend and participate.
- **Private vs. Public Settings:** While officials can participate in private club meetings, they must be cautious not to engage in discussions that would normally require a public forum, especially if a majority of a governing body is present.
- **Viewpoint Neutrality:** Government officials cannot silence speakers or discriminate against viewpoints in public forums, even if the speech is unpopular or critical, unless it is genuinely disruptive.
- **No Special Favors:** Officials should not use their position to ask for special favors from staff or private businesses, as this can erode trust and overstep boundaries of established protocol.
- **Conflict of Interest:** Leaders must be mindful of potential conflicts of interest, recusing themselves from decisions where they have a financial stake to maintain public trust.

By leading with integrity and respect, elected officials can effectively promote a **collaborative and inclusive** atmosphere in their communities without overstepping legal or ethical boundaries.

Re: Request for Muni code to protect Females residing in Fresno County-
