WHEREAS, the Sheriff-Coroner's Organization 3111 will receive \$49,357 from the California Governor's Office of Emergency Services (Cal-OES) for the Electronic Suspected Child Abuse Report System (ESCARS) Program to partially offset the cost of one (1) Information Technology Analyst position; and

WHEREAS, \$49,357 is not included in the appropriations and estimated revenues of the Sheriff-Coroner's Org 3111 for Fiscal Year 2017-18; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Sheriff-Coroner's Org 3111 as follows:

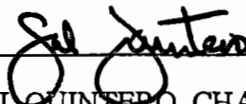

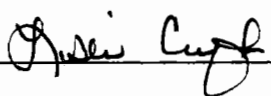
