8 WHEREAS, the County of Fresno will receive \$101,200 from the National Institute
9 of Justice, Department of Justice (DOJ) to reduce DNA casework backlog; and

10 WHEREAS, \$101,200 is not included in the adopted appropriations and estimated
11 revenues of the Sheriff-Coroner's ORG 3111 for Fiscal Year 2018-19; and

12 WHEREAS, Section 29130 of the Government Code provides for the appropriation
13 of these funds by a four-fifths vote of the Board of Supervisors;

14 NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax
15 Collector be authorized to increase the Fiscal Year 2018-19 appropriations for the
16 Sheriff-Coroner's ORG 3111 as follows:

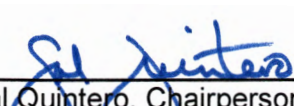

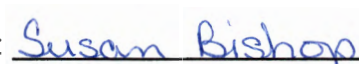
