WHEREAS, the County of Fresno, Internal Services Department - Information Technology Division purchased and implemented a new Environmental Health Data Management System (AMANDA) in the fiscal year; and

WHEREAS, the costs will be financed with revenue from Public Health Org 5620; and

WHEREAS, the Public Health Org 5620 will receive \$450,000 as an Operating Transfer In from the Public Health Fund 0080, Subclass 17358, Solid Waste Enforcement Tipping Fee Org 1158; and

WHEREAS, the Public Health Org 5620 will receive \$300,000 as an Operating Transfer In from the Public Health Fund 0080, Subclass 17362, Certified Unified Program Agency Fines Org 1162; and

WHEREAS, said monies are not included in the FY 2018-19 adopted appropriations and estimated revenues of the Public Health Org 5620; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2018-19 Public Health Org 5620 as follows:

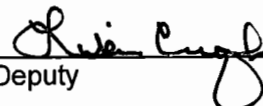
