WHEREAS, at the request of this Board, Department of Public Works and Planning staff has reviewed the budgets prepared for the County Service Areas (CSAs), a Highway Lighting District (HLD), Maintenance Districts (MDs), and Waterworks Districts (WWDs), based on the rates as set forth in Exhibit 1 hereto and has recommended that these budgets be established in Fiscal Year 2021-22; and

NOW, THEREFORE, BE IT RESOLVED, that the budgets calculated on the assessments, fees, charges and recovered costs, as set forth in Exhibit 1, for the CSAs, HLD, MDs, and WWDs shall be adopted for Fiscal Year 2021-22.

BE IT FURTHER RESOLVED, that the charges contained in the budget shall become effective July 1, 2021, and shall be published in the Master Schedule of Fees, Charges and Recovered Costs for administrative purposes only when the same is adopted for Fiscal Year 2021-22.


