ORGANIZATION 3111 IN THE AMOUNT OF \$100,000

RESOLUTION

WHEREAS, the Sheriff-Coroner-Public Administrator Organization (Org) 3111 will receive \$100,000 as an Operating Transfer-In from the Sheriff-Coroner Special Revenue Fund 0095, Federal Asset Forfeiture Treasury Org 1466 to purchase two vehicles; and

WHEREAS, said monies are not included in the FY 2025-26 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2025-26 Sheriff-Coroner-Public Administrator Organization 3111 as follows:
