ORG 8870 IN THE AMOUNT OF \$4,485,275 )

WHEREAS, the Department of Public Works and Planning, Capital Projects Org 8870 requires an increase in appropriations and estimated revenues in the amount of \$4,485,275 to fund the Kearney Park Improvement project to respond to the negative impacts of the COVID-19 public health emergency; and

WHEREAS, said monies were not included in the FY 2022-23 adopted appropriations and estimated revenues of the Capital Projects Org 8870 for this purpose; and

WHEREAS, the Auditor-Controller/Treasurer-Tax Collector (ACTTC) – Disaster Claiming Fund 0026, Subclass 91021, ACTTC– Disaster Claiming Org 1033, received American Rescue Plan Act – Coronavirus State and Local Fiscal Recovery Funds to meet the needs as Operating Transfer In to the Capital Projects Org 8870; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the ACTTC is authorized to increase the appropriations in the FY 2022-23 Capital Projects Org 8870 as follows:


