WHEREAS, funds are needed to purchase the property located at 2126-2140 Merced Street,
Fresno, CA 93721 (APN 466-152-01) to provide County office space in the current year; and

WHEREAS, the Hall of Records Improvements, Organization (Org) 8861 will have
\$1,950,750 available for the purchase of property; and

WHEREAS, the County Buildings Org 0131 will receive \$1,950,750 as an Operating Transfer
In from the Hall of Records Improvements, Org 8861 to purchase the property; and

WHEREAS, said monies are not included in the adopted appropriations and estimated
revenues for the FY 2025-26 County Buildings, Org 0131 for this purpose; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these
funds by a 4/5ths vote by the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector
is authorized to increase the appropriations in the FY 2025-26 County Buildings, Org 0131 as
follows:


