WHEREAS, the State of California 9-1-1 Emergency Communications Office has allocated \$52,994 for the replacement of Sheriff-Coroner's Dispatch seating and computer equipment; and

WHEREAS, the County of Fresno, will receive \$52,994 from the State of California 9-1-1 Emergency Communications Office for Sheriff-Coroner's Dispatch seating replacement and computer equipment; and

WHEREAS, \$52,994 is not included in the adopted FY 2015-16 appropriations and estimated revenues of the Sheriff-Coroner ORG 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations for FY 2015-16 for the Sheriff-Coroner ORG 3111 as follows:




