**SUMMARY OF ORDINANCE**

The proposed ordinance amends Chapter 2.64 to Title 2 of the Fresno County Ordinance Code relating to the Assessment Appeals Board. The proposed ordinance adds subsection §2.64.060, which is a fee waiver option for applicants claiming to be low income or otherwise unable to pay the \$86 Assessment Appeal Application processing fee.
