That the County is hereby authorized and directed to apply for and accept their HOUSING 24 NAVIGATORS Allocation award, as detailed in the Allocation Acceptance form, up to the amount 25 authorized in the Allocation Acceptance form and applicable state law. 26 27 SECTION 2. That if funds remain available for allocation after the deadline for submitting a signed 28 Allocation Acceptance Form, and if the Department advises County that County is eligible for an

1	additional allocation from these remaining funds, County is hereby authorized and directed to accept	
2	this additional allocation of funds ("Additional HNP Allocation") up to the amount authorized by	
3	Department.

5	SECTION 3. That Delfino E. Neira, Director of Social Services, or his or her designee, is hereby	
6	authorized and directed to act on behalf of County in connection with the HNP Allocation Award and	
7	any Additional HNP Allocation, and to enter into, execute, and deliver any and all documents required	
8	or deemed necessary or appropriate to be participate in the Program and be awarded the HNP	
9	Allocation Award, and any Additional HNP Allocation, and any amendments to such documents	
10	(collectively, the "HNP Allocation Award Documents").
