

NOTICE is hereby given that at its regularly scheduled meeting on June 10, 2025, the Fresno County Board of Supervisors adopted Ordinance No. 25-013, an Ordinance of the County of Fresno, State of California.
SUMMARY OF ORDINANCE
The Proposed Ordinance will amend Section 600 of the County of Fresno Master Schedule of Fees, Charges and Recovered Costs Ordinance - County Counsel, by amending Subsection 601 (Attorney Services) relating to County Counsel's recovery of costs of attorney services (increasing the fee rate for such services to \$182 per hour for each attorney) provided by County Counsel to County departments and other public agencies; such ordinance amendment is proposed to be effective July 10, 2025.
