WHEREAS, the County of Fresno Sheriff Org 3111 will receive \$2,600,000 from the U.S Department of Justice, United States Marshals Services (USMS) for housing of Federal detainees in the Fresno County Jail to offset Salaries and Benefits expenditures; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator's Organization 3111; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors:

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 Sheriff-Coroner-Public Administrator's Organization 3111 as follows:


