WHEREAS, \$5,000 is not included in the appropriations and estimated revenues of the Sheriff-Coroner Organization 3111 for FY 2018-19; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the FY 2018-19 appropriations in the Sheriff-Coroner Organization 3111 as follows:
