Location: 25430 W Dorris Ave, Coalinga, CA 93210



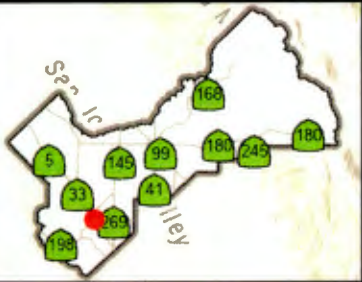
