WHEREAS, the Central Library 2nd Floor Renovation Project costs are estimated at \$202,500;
and

WHEREAS, the 2019-20 Library Measure B - Capital Improvements Org 7530 requires an
additional \$202,500 of appropriations to fund an Operating Transfer Out for the costs associated with the
renovations needed to create additional office space on the second floor of the Central Library building;
and

WHEREAS, \$202,500 is available in the Measure B fund balance of the Fresno County Library to
fund these expenditures; and

WHEREAS, said monies are not included in the FY 2019-20 adopted appropriations and
estimated revenues of the Library Capital Improvements Organization 7530; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds
by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is
authorized to increase the appropriations in the FY 2019-20 Library Capital Improvements Org 7530 as
follows:

2 Improvements Org 7530 are available in the Measure B Fund balance.


