As noted, **please be prepared to present** your case at the Board of Supervisors' meeting. The following criteria will need to be provided **in writing** to the Board of Supervisors.


County policy provides that the following three criteria be met before a determination of public convenience or necessity can be made:

EXISTING ZONING MAP


