SUPERVISOR BRANDAU ANNOUNCED THAT THE SHERIFF WILL CLOSE THE SAN JOAQUIN RIVER FOR RECREATIONAL USE DUE TO THE PRESENT DANGER. COUNTY ADMINISTRATIVE OFFICER (CAO) NERLAND CLARIFIED BOTH THE SAN JOAQUIN AND KINGS RIVERS WILL CLOSE FOR RECREATIONAL USE AND ANNOUNCED A MEDIA BRIEFING REGARDING THE STORMS IS SCHEDULED FOR 1:30 PM TODAY AT THE COUNTY'S EMERGENCY OPERATION CENTER (EOC). VICE CHAIRMAN MAGSIG RECALLED COMMUNICATING WITH THE OFFICES OF SENATOR SHANNON GROVE AND SPEAKER KEVIN McCARTHY ABOUT POSSIBLE STATE OR FEDERAL FUNDING FOR RURAL AREAS DISPROPORTIONATELY IMPACTED BY THE STORMS; AND THANKED THE HIGHWAY PATROL, CALIFORNIA DEPARTMENT OF TRANSPORTATION (CALTRANS), SHERIFF'S DEPARTMENT AND PUBLIC WORKS FOR PROTECTING FRESNO COUNTY RESIDENTS DURING THESE STORMS. SUPERVISOR MENDES REFERENCED THE SNOW LEVELS OF 1982-1983 TO COMMENT ON THE AFTER-EFFECTS OF THE ON-GOING STORMS. SUPERVISOR PACHECO THANKED THE COUNTY OFFICE OF EMERGENCY SERVICES (OES) AND NOTED THAT ONCE THE RAIN STOPS, MANY WESTSIDE COMMUNITIES WILL CONTINUE TO FACE THE THREAT OF FLOOD AS THE SNOW MELTS. CHAIRMAN QUINTERO THANKED THE COUNTY OFFICES, INCLUDING DAN LYNCH WITH OES, THAT ARE AVAILABLE TO ADDRESS CONSTITUENT CONCERNS; THANKED THE SHERIFF'S OFFICE FOR WORKING WITH HOMELESS ADVOCATES TO HELP EVACUATE PEOPLE ALONG THE SAN JOAQUIN RIVER AND IN THE FRIANT-KERN CANAL AREA; AND THANKED SUPERVISORS PACHECO AND MENDES FOR PROVIDING CONSTITUENTS CLARIFICATION ON SANDBAGS AND OTHER SERVICES, ESPECIALLY IN THE RURAL AREAS. CAO NERLAND THANKED THE BOARD FOR ACKNOWLEDGING EMERGENCY SERVICES; ACKNOWLEDGED THE COUNTY'S PUBLIC INFORMATION TEAM FOR GETTING CLEAR INFORMATION OUT TO THE COMMUNITY; AND ANNOUNCED THAT CURRENT COUNTY OF KINGS CAO ED HILL WILL BE THE COUNTY OF FRESNO'S NEW CHIEF OPERATING OFFICER ON APRIL 17
