

PUBLICATION OF SUMMARY OF PROPOSED ORDINANCE BOARD OF SUPERVISORS COUNTY OF FRESNO

The Fresno County Board of Supervisors is giving notice that at their regularly scheduled meeting on November 5, 2024, at 9:30 a.m., or as soon thereafter as the matter may be heard, at the Fresno County Hall of Records, Board of Supervisors Chambers, 3rd Floor, 2281 Tulare Street, Fresno, California, they will consider adoption of the ordinance summarized below.

SUMMARY OF PROPOSED ORDINANCE

The Ordinance to add 15.90, to Title 15 of the County of Fresno Ordinance Code (the "Ordinance Amendment") to declare unsecured vacant buildings to be a public nuisance; to protect public health, safety, and welfare; to regular unsecured vacant buildings in commercial, industrial and residential zoned districts; to authorize abatement of unsecured vacant residential buildings in any zoned district found to be substandard; to provide standards to property owners to secure vacant buildings; to authorize abatement of unsecured vacant buildings; to discourage the illegal activities and other nuisance conditions attracted to vacant buildings; and to encourage vacant buildings be returned to a productive use.
