WHEREAS, the Protective Services Subaccount Organization 6210 requires additional funding in the amount of \$868,842 to increase appropriations and estimated revenues in the DSS - Dependent Children - Foster Care Organization 6410 in order to make mandated assistance payments; and

WHEREAS, the Protective Services Subaccount Organization 6210 will receive an additional \$868,842 in revenues from the State of California for unbudgeted Foster Care Assistance Growth; and

WHEREAS, the \$868,842 is not included in the FY 2014-15 adopted appropriations and estimated revenues of the Protective Services Subaccount Organization 6210; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a 4/5 vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2014-15 budget of the Protective Services Subaccount Organization 6210 as follows:
