WHEREAS, the Department of Public Health Organization 5620 requires
\$200,000 to correct a revenue budget estimate on mandated surcharges, that
are required to be sent to the State; and

WHEREAS, the Department of Public Health Organization 5620 will receive
\$200,000 as an Operating Transfer In from Special Revenue Fund 0080, Org
1157; and

WHEREAS, said monies are not included in the FY 2022-23 adopted
appropriations and estimated revenues of the Department of Public Health
Organization 5620; and

WHEREAS, Section 29130 of the Government Code provides for the
appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-
Tax Collector is authorized to increase the appropriations in the FY 2022-23
Department of Public Health Organization 5620 as follows:


