SUBJECT: 2026 Chairman's Appointments and California Form 806

RECOMMENDED ACTION(S):

Approve the Chairman's 2026 Appointments of Board Members to various Boards, Commissions and Committees as presented in Exhibit A; and adopt California Form 806 (Agency Report of Public Official Appointments) as presented in Exhibit B, and direct the Clerk of the Board to post on the County's website.

There is no additional Net County Cost associated with the recommended item. Approval of the recommended action will appoint Board Members to various Boards, Commissions, and Committees listed in Exhibit A. Approval of this action would also adopt the California Form 806 as presented in Exhibit B and post said form to the County's internal website. This item is countywide.

ALTERNATIVE ACTION(S):

If your Board wishes to make changes to the Chairman's 2026 assignments, your Board may articulate specific requests. If your Board does not approve the California Form 806 - Agency Report of Public Official Appointments, the County will not achieve compliance with the California Fair Political Practices Commission (FPPC) Regulation 18705.5.

FISCAL IMPACT:

There is no additional Net County Cost associated with the recommended actions.

DISCUSSION:

At their first regular meeting of the year, the Board of Supervisors formally approves their Board and Committee assignments for the year. Attached as Exhibit A is a list of the various boards, commissions, and committees on which the members of the Board of Supervisors serve and a roster of current assignments, which was last approved by your Board on July 8, 2025.

In March 2012, the FPPC amended Regulation 18705.5, creating a limited exception to allow public officials to vote on their appointment as representatives of the entity to other paid public boards. The FPPC also required the use of Form 806 (Agency Report of Public Official Appointments) for public agencies to identify these appointments. Since 2013, Form 806 has been used to report additional compensation received by elected officials when appointing themselves to positions on committees, commissions or boards for public agencies, special districts, or joint powers agencies or authorities. Attached as Exhibit B is Form 806, which will be posted on the Fresno County website and will be updated as changes occur.

Approval of the recommended actions will confirm the committee assignments for Board members in 2026, with the Form 806 reporting any assignments where Board members receive additional compensation.

Any changes to the approved assignments during the year must be brought before the Board for consideration and approval.
