On September 26, 2017, the County conducted the first hearing to adopt the Ordinance to amend the Fresno County Master Schedule of Fees, Charges and Recovered Costs, by amending Subsection 2609 of Section 2600, related to fees charged to recover costs of contract services provided by Sheriff's Department personnel to other agencies.
