WHEREAS, the Fresno County Sheriff will receive \$55,980 for miscellaneous equipment (Radio siren/PA controller, two (2) Rescue Sleds Repower-Replacement of motor, gauges, steering, bow lights, shift and throttle, chairs, depth finder, flooring, small trolling type motor, swim step, bimini top, and engine covers) from the State of California Department of Parks and Recreation Division of Boating and Waterways; and

WHEREAS, said monies are not included in the appropriations and estimated revenues of the Sheriff-Coroner-Public Administrator Org 3111 for Fiscal Year 2025-26; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the Fiscal Year 2025-26 Sheriff-Coroner-Public Administrator Org 3111 as follows:


