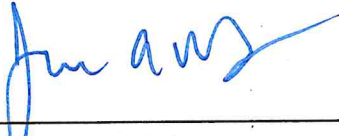
CERTIFICATE OF COUNTY CLERK TO RESULTS OF THE CANVASS

Furthermore, this election is hereby certified in honor of Julie Marie Grant, Fresno County Resident, retired Fresno County employee, and long-time Election Worker. Julie retired as an Account Clerk III from the Fresno County Clerk/Registrar of Voters in 2012 after fourteen years of county service. She quickly returned to public service, first as an elections volunteer and then as an extra-help Election Worker, assisting with almost every election through November 2024. Julie was instrumental in implementing the beloved drive-through ballot drop off downtown and facilitated the counting of almost every Vote by Mail ballot through her management of dozens of Election Workers unfolding and flattening every ballot prior to tabulation.

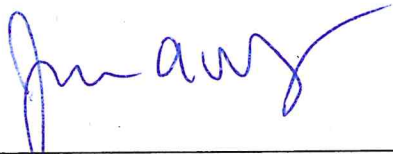
