WHEREAS, said monies are not included in the FY 2017-18 adopted appropriations and estimated revenues of the Jail Improvements Organization 8852; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote of the Board of Supervisors:

NOW, THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2017-18 Jail Improvements Organization 8852 as follows:
