According to the Maternal and Infant Health Assessment (MIHA), in 2024, the breastfeeding initiation rate in California was 90%, while the exclusive breastfeeding rate was 87.8% for the surveyed period. In contrast, in 2024, Fresno County reported a breastfeeding initiation rate of 68%, while the exclusive breastfeeding rate in Fresno County was 55% for the surveyed period; and |
