WHEREAS, there is available fund balance in the Local Revenue Fund 2011 Fund 0271 to fund the reimbursement of the Human Resources Department for staff time related to the AB 109 Planning Grant; and

WHEREAS, the AB 109 Planning Grant Organization 3439 requires an increase in appropriations in the amount of \$146,268 to fund the reimbursement of the Human Resources Department for staff time related to the AB 109 Planning Grant; and

WHEREAS, \$146,268 is available in the fund balance of the Local Revenue Fund 2011 Fund 0271, to fund the additional cost; and

WHEREAS, said monies were not included in the adopted appropriations for the FY 2020-21 AB 109 Planning Grant Organization 3439; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2019-20 AB 109 Planning Grant Organization 3439 as follows:


