IN THE MATTER OF LOCAL TRANSPORTATION) RESOLUTION
PURPOSE FUNDS FOR FISCAL YEAR 2025-2026)

WHEREAS, the County of Fresno is an eligible claimant of funds for Measure C Extension Local Transportation Pass-Through Projects and Program Funds pursuant to California Public Utilities Code Section 142257; and

WHEREAS, the Fresno County Transportation Authority has adopted a Resolution of Apportionment for Fiscal Year 2025-2026 Measure C Extension Local Transportation Pass-Through Projects and Program Funds, setting the County of Fresno's percentages at the following amounts:

- 25.69% of \$593,732 (\$152,537) for the Local Transportation Program, Local Allocation – ADA Compliance Category sub program;
- 30.09% of \$883,905 (\$265,967) for the Local Transportation Program, Local Allocation – Bicycle Facilities sub program;
- 24.81% of \$16,950,102 (\$4,205,674) for the Local Transportation Program, Local Allocation – Flexible Funding Category sub program;
- 68.94% of \$587,213 (\$404,797) for the Local Transportation Program, Local Allocation – Pedestrian/Trails – Rural sub program;
- 5.66% of \$2,383,799 (\$134,942) for the Local Transportation Program, Local Allocation – Pedestrian/Trails – Urban sub program;
- 25.69% of \$16,963,777 (\$4,358,211) for the Local Transportation Program, Local Allocation – Street Maintenance Category sub program;

which shall be the proportionate share of Measure C Extension Local Transportation Pass-Through Projects and Program Funds that the County of Fresno shall be entitled to within the fiscal year.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1) The County of Fresno hereby submits its Local Transportation Purposes Certification and Claims for Fiscal Year 2025-2026 Measure C Extension Local Transportation Pass-Through Projects and Program Funds;

- 1 2) The County of Fresno hereby requests the release of funds to the County on a
2 monthly payment basis consistent with the adopted percentages listed above,
3 based on actual receipts;
- 4 3) The Board of Supervisors of the County of Fresno further certifies:
- 5 a) That Local Transportation Purpose Funds will not be used to substitute
6 for property tax funds which the County of Fresno had previously used, or
7 currently uses, to fund existing local transportation programs; and
- 8 b) That the County of Fresno has, and will, segregate property tax revenues
9 used to support local transportation purposes so that verification of non-
10 substitution can be proved through audit and:
- 11 c) That the County of Fresno shall separately account for Local
12 Transportation Purposes Funds received, pursuant to Public Utilities
13 Code Section 142257. The County shall maintain records in accordance
14 with generally accepted accounting principles and shall separately record
15 expenditures for each type of eligible purpose. The County shall make
16 such records available to the Fresno County Transportation Authority for
17 inspection or audit at any time.
- 18 4) The County of Fresno understands that should a financial or compliance audit
19 reveal that the County of Fresno violated any of the requirements set forth
20 herein, the Fresno County Transportation Authority may seek to take immediate
21 steps to resolve the violation in accordance with its adopted procedures and
22 applicable law.
- 23 5) The County of Fresno understands that reporting requirements for the previous
24 fiscal year's funds must be completed no later than November 15, 2025, to avoid
25 the withholding of monthly disbursements.


