SERVICES, ORG 5110 IN THE AMOUNT OF \$650,000 ) RESOLUTION

WHEREAS, the Department of Child Support Services Org 5110, requires an increase in appropriations in the amount of \$650,000 to allow for the payment of costs related to facility upgrades and remodel projects of the 3<sup>rd</sup> Floor of the County Plaza Building; and

WHEREAS, the Department of Child Support Services will receive additional revenue coming from the 2020 Federal Corona Aid, Relief, and Economic Securities (CARES) Act funding for pandemic response for assisting the Department of Public Health with COVID-19 related activities in the amount of \$572,188; and

WHEREAS, the Department of Child Support Services will also receive additional revenue from the Fresno County Clerks/Elections for assisting with election related activities in the amount of \$77,812; and

WHEREAS, the Department of Child Support Services will receive a total amount of \$650,000 in additional funding for FY 2020-21; and

WHEREAS, said monies are not included in the FY 2020-21 adopted appropriations and estimated revenues for the Department of Child Support Services Org 5110; and

WHEREAS, Section 29130 of the Government Code provides for the appropriations of these funds by a four-fifths vote by the Board of Supervisors;

NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in FY 2020-21 Department of Child Support Services, Org 5110 as follows:
