at the City of Bakersfield. The computer forensic lab confirmed the authenticity of the emails dated 1/18/2017 with the subject "Home Address." The emails are an exchange between (b)(6), (b)(7)c and (b)(6), (b)(7)c where City of Bakersfield staff ask and receive a copy of (b)(6), (b)(7)c Safe at Home participant identification card.

During the course of the investigation, we interviewed (b)(6), (b)(7)c, (b)(6), (b)(7)c, and (b)(6), (b)(7)c. The investigation found a concerted effort by (b)(6), (b)(7)c and (b)(6), (b)(7)c at the City of Bakersfield to provide false statements to investigators, Kern County employees, and Superior Court officials.

(b)(6), (b)(7)c, a confidential informant with the City of Bakersfield confirmed that (b)(6), (b)(7)c and (b)(6), (b)(7)c attempted to destroy records and provide false statements in an attempt to conceal misconduct and/or tortious acts. Agent (b)(6), (b)(7)c asked (b)(6), (b)(7)c to call (b)(6), (b)(7)c former Deputy City Attorney for the City of Bakersfield and ask questions about his recollection of (b)(6), (b)(7)c confidential address and who at the city was aware of (b)(6), (b)(7)c participation in the Safe at Home program. (b)(6), (b)(7)c returned the victim's call at approximately 17:11 Pacific time and the call was recorded by Officer (b)(6), (b)(7)c. The call lasted approximately 12 minutes.

During this call (b)(6), (b)(7)c stated:

"Well, it has been quite awhile, I don't remember when exactly you first submitted that card [referred to the Safe at Home identification] or we had this conversation originally; that was years ago [um]; I know it has come up at different times [um] and that you raised the issue several times but as far as specifically what [um] we did with it; I know that [um]; I don't recall that we did anything with it honestly; I think we communicated to everyone that [um] that was involved that that [home] address was subject to limitations and [um] [um] there was supposed to be sensitivity in how it was used, used only in particular situations that were designated in the law [um] so [um] yeah I don't have specific recollection of conversations that we had at the time we first received your address, I know that we, I know that we clearly articulated it, I know to community development was obviously the holder of that information through your purchase of the house [um], and so I think they were aware of the situation as far as I understood and [um] I am sure the clerk was as I recall because there were some, I think you had submitted some public records requests, if I remember correctly, um, so yeah I, I don't have a specific recall of conversations or what was done to make sure it was protected but I know that we made it very clear, we understood the issue and made it very clear to notice the projects we worked with th you know it is supposed to be only utilized in certain situations" - or words to that effect.

(b)(6), (b)(7)c indicated that "Ginny" had been briefed and was aware of (b)(6), (b)(7)c confidential address and asked if (b)(6), (b)(7)c had reached out to her for assistance. (b)(6), (b)(7)c went on to say "I think you definitely should, if the [city] manager hasn't done so already, definitely reach out to Ginny, I mean obviously [um], I've been gone for almost a year and know that the issue was ongoing, you know, that you raised this several times over the course of years, so [um] I wouldn't know why that was posted or how that was posted or any of that" - or words to that effect.

The investigation has concluded that (b)(6), (b)(7)c (Bakersfield city attorney) and (b)(6), (b)(7)c (Bakersfield city staff) had knowledge of (b)(6), (b)(7)c participation in the Safe at Home program as of January 2017 and encouraged other city staff to destroy records and deceive law enforcement, court, and state personnel about the posting of (b)(6), (b)(7)c address on Bakersfield's municipal website.

The investigation remains ongoing to determine if Mayor (b)(6), (b)(7)c, Vice Mayor (b)(6), (b)(7)c, Councilmember (b)(6), (b)(7)c, and City Manager (b)(6), (b)(7)c committed any offenses.
