WHEREAS, the Sheriff’s State Asset Forfeiture Organization 1460 requires \$248,792 to meet estimated expenditures associated with the costs to repair and upgrade the Sheriff Office’s helicopter’s Forward Looking InfraRed (FLIR); and

WHEREAS, \$1,176,351 is available in the fund balance of the Sheriff-Coroner Special Revenue Fund 0095, Subclass 17659 to fund these expenditures; and

WHEREAS, said monies are not included in the FY 2022-23 adopted appropriations and estimated revenues of the State Asset Forfeiture Org 1460; and

WHEREAS, Section 29130 of the Government Code provides for the appropriation of these funds by a four-fifths vote of the Board of Supervisors;


NOW THEREFORE, IT IS ORDERED that the Auditor-Controller/Treasurer-Tax Collector is authorized to increase the appropriations in the FY 2022-23 State Asset Forfeiture Org 1460 as follows:
